On behalf of the Brazilian Federal Agency for Support and Evaluation of Graduate Education (CAPES), I take this opportunity to invite China Education Association for International Exchange (CEAIE) to lead a Chinese University delegation (name's list are attached) to participate in a Brazil-China University Rectors' Forum, which will be co-hosted by CAPES and CEAIE, on October 29th, 2024, at Brasilia, Brazil.
